## **Code of Conduct**

#### For teachers

- **Q1**: *Is there a Code of Conduct for teachers and all personnel working in the* [specify: school / learning space]?
- A1: Yes for all personnel / Yes for teachers only / No / Don't know / Refuse to answer

(ask the following question only if the previous answer is YES)

- Q2: Were you informed about/trained on the Code of Conduct and its contents?
- A2: Yes thoroughly/ Yes to a degree / No / Don't know / Refuse to answer
- **Q3**: Have you signed the Code of Conduct?
- A3: Yes / No / Don't know / Refuse to answer
- Q4: What is the purpose of the Code of Conduct?

**A4**:

- 1. the [teacher / [specify: school / learning space] personnel/community member] understands the Code of Conduct's purpose

  - 3) Can a teacher shout at a child because he/she disobeyed him/her? (Yes/No)
  - 4) Can a teacher ask children to help them with class chores? (Yes/No)
  - 5) Can a teacher touch a child's body even though the child seems uncomfortable? (Yes/No)
  - 6) Can a teacher hit a child with a stick if the child has bullied another child? (Yes/No)

**Provide 1 score for each correct answer** (YES to S2 and S4; NO to S1, S3, S5 and S6). (go to Question 3)

**Q3:** What can a child do when s/he knows that the teacher / personnel is doing something that is strongly against the content of the Code of Conduct for Teachers / personnel?

A3: pre-define the options based on the locally available possibilities + add options 1) does not know; and 2) other – specify:\_\_\_\_\_ (end interview)



If the interviewee 1) knows about Code of Conduct, 2) scores at least 5 out of 6 points on Q2, and 3) knows how to report teachers'/personnel misconduct, s/he is considered 'being informed' about the Code of Conduct.
